## 1. Acceptance of Terms

By continuing with your booking, you confirm that you have **read, understood, and agree** to these Terms & Conditions. Acceptance of these Terms is required before participation in any activity delivered by 1141 Adventures.

---

## 2. Scope of Services

These Terms apply to all activities, courses, instruction, and services provided by 1141 Adventures anywhere in the United Kingdom, including **England, Wales, and Scotland**, and are delivered in accordance with applicable legislation, Adventure Activities Licensing requirements, and insurer conditions.

---

## 3. Bookings & Payment

A booking is confirmed only once the required deposit or full payment has been received.

- Deposits are **non-refundable**, except where required by law
- Outstanding balances must be paid by the stated deadline
- Failure to pay may result in cancellation without refund

---

## 4. Participant Responsibilities

All participants must:

- Follow instructor instructions at all times
- Act responsibly and within their physical and mental limits
- Treat staff, other participants, landowners, and the environment with respect
- Inform instructors immediately of illness, injury, fatigue, or concerns

Failure to comply may result in removal from the activity without refund.

## 5. Fitness & Medical Disclosure

Participants must complete a medical declaration and disclose all relevant medical conditions, injuries, medications, or concerns.

Participants agree to:

- Notify 1141 Adventures of any change in medical condition or fitness
- Accept that failure to disclose relevant information may result in exclusion

---

## 6. Participants Under 18

Participants under the age of 18:

- **Must be accompanied by a parent or legal guardian**, in line with Adventure Activities Licensing requirements
- Require parental or guardian consent
- Remain the responsibility of the accompanying adult

---

## 7. Safety & Instructor Authority

Instructors have full authority to:

- Modify routes, objectives, or activities
- Reduce activity scope
- Suspend or cancel activities
- Remove participants where safety is compromised

All safety decisions are final and are not subject to commercial consideration.

---

## 8. Assumption of Risk

Participants acknowledge that adventure activities involve **inherent and unavoidable risks**, including those arising from:

- Terrain and environmental conditions

- Weather and remoteness
- Physical exertion

Participation is voluntary, and participants accept these inherent risks.

---

## **9. Participation Statement & Waiver**

All participants must complete a Participation Statement and Waiver before taking part.

This confirms:

- Understanding of the activity and its risks
- Voluntary participation
- Acceptance of the legal principle of *volenti non fit injuria*

Nothing in these Terms excludes or limits liability for death or personal injury caused by negligence or breach of statutory duty.

## **10. Changes or Cancellation by 1141 Adventures**

1141 Adventures reserves the right to modify, postpone, or cancel activities due to:

- Weather or environmental conditions
- Safety concerns
- Instructor illness
- Equipment failure
- Access restrictions

Safety-based decisions do not constitute a breach of contract.

## **11. Equipment & PPE**

Participants must:

- Use all equipment and PPE as instructed
- Report defects immediately
- Accept that misuse of equipment may result in exclusion

---

## 12. Environmental Responsibility

Participants agree to:

- Follow Leave No Trace principles
- Respect wildlife, habitats, and access guidance
- Follow instructor direction to minimise environmental impact

---

## 13. Photography & Media Consent

Photographs or video recordings **may be taken during activities** and used for promotional purposes, including websites and social media.

- Consent is requested during booking
- Consent may be declined or withdrawn at any time
- Safeguarding and privacy are respected
- Parental or guardian consent is required for children

---

## 14. Data Protection

Personal data is processed in accordance with **UK GDPR** and the Data Protection Act 2018.

- Medical data is treated as special category data
- Data is stored securely
- Access is restricted to those with a legitimate safety or operational need
- Data is retained only as long as necessary

---

## 15. Insurance

1141 Adventures holds appropriate Public Liability, Professional Indemnity, and Employer's Liability insurance.

Participants are responsible for arranging their own personal accident, medical, and cancellation insurance.

## 16. Complaints

Complaints will be:

- Acknowledged within 7 days
- Investigated fairly
- Responded to in writing
